


## YouTube contest LanguageLearningPortal.com

Terms and Conditions



## **Terms and Conditions**

- 1. The YouTube contest LanguageLearningPortal.com (the "Contest") is open to people aged 16 and over.
- 2. Employees of StudyPortals or their family members, or anyone else connected with the Contest may not enter the Contest.
- 3. Entrants into the Contest shall be deemed to have accepted these Terms and Conditions.
- 4. To enter the Contest you must complete the Contest form (<a href="http://www.jotformpro.com/form/43001758601951">http://www.jotformpro.com/form/43001758601951</a>) and submit your contact details and the YouTube link.
- 5. Only one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 6. No responsibility is taken for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by StudyPortals.
- 7. The deadline for submitting videos is 19 December 2014. Entries received after this date will not be considered.
- 8. The Contest ends on **19 December** 2014, 16.00h (GMT+1). This is the moment that the amount of views for the submitted YouTube videos are counted, which will determine the 5 Contest participants who have the videos with the most views (the finalists).
- 9. A jury consisting of StudyPortals employees will judge the 5 finalists on (1) originality, (2) their reason to learn/improve chosen language, (3) how well it inspires others to learn another language. The finalist with the highest jury score (the Winner) will receive the 1<sup>st</sup> prize. The other 4 finalist will receive a € 20 Amazon Gift Voucher as a prize via their provided email address.
- 10. The 1<sup>st</sup> prize is a language holiday on the language that the Winner has mentioned in his/her video as the language he/she wants to learn/improve. StudyPortals will select the language holiday, taking into account the preferences of the Winner if possible. The language holiday includes a language course, travel, and accommodation up to € 800 (including VAT).
- 11. The winner will be notified by email or telephone on or before 22 December 2014 and must provide a postal address to claim their prize. If a winner does not respond to StudyPortals



within 3 days of being notified by StudyPortals, then the winner's prize will be forfeited and StudyPortals shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 3 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and StudyPortals shall be entitled to select another winner.

- 12. StudyPortals accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from the location where the language holiday takes place).
- 13. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
- 14. StudyPortals retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available.
